01 What are Patent Technological Reports?

These reports provide an in-depth analysis of the patents published world-wide and their relationship to a particular technical issue.

02 What are they for?

- For planning any R&D activity
- For analysing the potential patentability of the obtained results
- For writing a patent
- For solving specific technical problems
- For learning about new projects or lines of research
- For evaluating a license agreement
- For detecting public domain technologies
- For preventing possible infringements

03 How are they drawn up?

Patent Technological Reports are drawn up by qualified SPTO (Spanish Patent and Trademark Office) specialists who remain in direct contact with the requester in order to ensure that the search matches the needs expressed as closely as possible.

To carry out the reports the SPTO uses:

- World-wide databases
- Documentary resources of major industrialised countries



04 Content/structure

A Patent Technological Report consists of the following core sections:

1. Technical object of the search: detailed presentation of the technical matter referred to in the report.
2. Search profile: list of the criteria used to recover the information.
 - International Patent Classification
 - Key words
 - Companies in the sector
3. Search result: The most relevant documents recovered.
4. Comment: The basics steps of a search, the most important content in the documents, and other matters that enable the user to interpret the report are explained.
5. List of references: The bibliographic references of the recovered documents that are related to the object of the search are attached in an annex, including a link to consult the document online.
6. Annexes: the databases used and an explanation of the codes and other terms used in the report.
